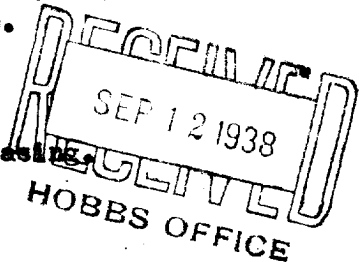

At 1 PM, Sept. 7, 1938 well was shot with 215 quarts of SNB from 3505' to 3595' with 15' plain anchor on bottom. Shot exploded with Zero Hour Bomb.
