On October 30, 1974, the New Mexico Oil Conservation Commission approved temporary abandonment of this well until October 1, 1975. The well was temporarily abandoned at an unknown date by the former operator as being uneconomical to operate, prior to unitization into the Myers Langlie-Mattix Unit 2-1-75. Present plans are to place the well in an active operating status in the first or second quarter of 1976. Skelly Oil Company respectfully requests that a one year extension to temporarily abandon this well be granted administratively per NMOCC Order No. R-5019. Water injection is presently being expanded on this unit.
