Previous perforations having been unsuccessful in obtaining production, it is proposed to set bridging plug at 6650', dump 5 sacks of calseal on top of plug, and perforate 7" casing from 6435' to 6490', 6500' to 6515', 6530' to 6560', 6575' to 6595' with six 15/32" Holes per foot to obtain oil and/or gas production. Present PB TD- 6766'.
