Pressure test ran early November 2001 failed - requested 30 days extension (12-26-2001) to locate problem/leak off so that repairs could be performed & well re-tested to retain TA status.

Have been unable to repair in the time extension granted - respectfully request extension to February 1, 2002 for repairs so that a successful csg integrity test can be performed to retain TA status for well.

This well is potential candidate for a future horizontal drilling program to develop the Paddock formation.
