DETAILS OF WORK

It is our intention to drill a well with rotary tools at the above location to a depth of approximately 9,300 feet unless commercial oil or gas production is encountered at a lesser depth. All casing will be cemented in accordance with methods approved by the U. S. Geological Survey. Any other special requirements will be complied with. The following casing pattern will be used:

- 13-3/8" Casing to be set at approximately 300 feet, cemented with 175 sacks.
- 9-5/8" Casing to be set at approximately 2,900 feet, cemented with 1300 sacks.
- 7" OD Casing to set at approximately 9,100 feet, cemented with 500 sacks.

This well will be produced from the McKee formation.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.




LEA COUNTY, NEW MEXICO


