Oil & wtr is produced into separate battery & sold via truck from this battery.  
Gas produced on wells #2 & #3 is sold thru a common meter to Sid Richardson with other Baylus Cade wells, including Teague Paddock-Blineby & Teague McKee.

Carter Foundation (drld first well on lease & first operator), Arch Petroleum, and Plains Petroleum Operating Co, previous operators sold gas thru this common meter. After researching files, could not locate any past request for surface commingling - to sell gas thru a common meter, although this has been done for quite sometime.

Respectfully request authority/permission to continue selling gas thru common meter, surface commingling for gas sales only. Gas will be allocated back to each individual well with monthly well tests as has been done in past.


