1. Pull rods, install BOP, pull tubing.
2. Clean out to 5110'.
3. Set CIBP @ 5050' w/ 35' cement on top using dump bailer.
4. Perforate Langlie Mattix 3100-3300'.
5. Acidize and frac Langlie Mattix if necessary.
6. Place well on production.
