A CIBP was set at 3050' and well was temporarily abandoned in September, 1993.

Plan to recomplete well to Yates Formation. Add perforations from 2558' to 2854' and acidize w/ 1200 gallons of 7.5% acid. Will frac all perforations 2558' - 2582'; 2598' - 2612'; 2696' - 2706'; 2716' - 2752'; 2790' - 2812'; and 2822' - 2854' with 175,000# of 20/40 and 12/20 sand. Frac job may be altered when job design is completed. Return well to production in Yates Formation.
