- 1) MI RU plugging contractor. Spot 35' of cmt on CIBP previously set @ 2742'.
- 2) Load casing with mud.
- 3) Spot 25 sx cement plug from 1400' - 1550'.
- 4) Perf csg @ 1200' and squeeze w/50 sx cement leaving 25 sx inside the casing.
- 5) Cut 7" casing at approx. 400'. Pull out of hole and lay down casing.
- 6) Spot 50 sx plug from 222' - 372'.
- 7) Spot 50 sx plug from 3' - 150'.
- 8) Remove wellhead. Install P&A marker.
- 9) Restore location.
