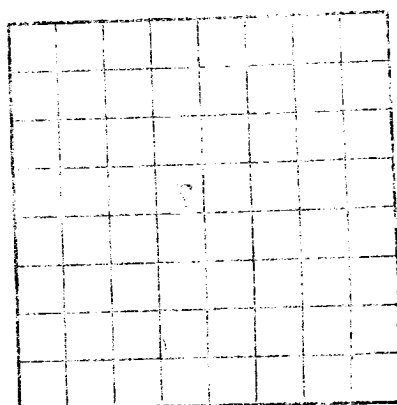

Since the gas production of this well was no longer needed to supply the demand in the subject field, a 10' Guberson Spiral - wrapped caskum packer was seated from 2,868 to 2,908. This effectively shut-off the upper gas bearing zone, but no oil was obtained from beneath the packer. In an effort to stimulate production, the formation from the packer to T.D. of 2,995 was treated with 2,000 gallons of 20% hydrochloric acid. No oil was obtained after this treatment; therefore, the well was abandoned 60' from its original total depth of 2,995 to its new total depth of 3,025. A formation packer was seated from 2,938 to 2,978 and the formation beneath the packer was treated with 2,000 gallons of 20% hydrochloric acid. On subsequent potential test, the well flowed 75 barrels of fluid, 40% oil, during 24 hours through 1 1/2" choke.

It is of the greatest importance to have a complete history of the well. Please state in detail the dates of redrilling, together with the reasons for the work and its results. If there were any changes made in the casing, state fully, and if any casing was "sidetracked" or left in the well, give its size and location. If the well has been dynamited, give date, size, position, and number of shots. If plugs or bridges were put in to test for water, state kind of material used, position, and results of pumping or bailing.
