Plugged perforated section from 5220' to 5010' with 25 sacks of cement. Circulated mud. While going in hole with 3 qts. shot of glycerine to shoot off 5 1/2" casing, shot discharged prematurely at 144'. Pulled 144' of 5 1/2" casing. Unable to recover additional casing; cemented from 144' to surface with 70 sacks.
