DETAILS OF WORK

Treated well on Oct. 31 with 1000 gal. Dowell mud acid in Ellenberger lime formation from 11890-11928' through 2" tubing under 900-1100# pressure. No reaction time. Was not pressure treated. Approximately 1 bbl. acid entered formation. Circulated acid out with pump pressure. Test after acid treatment well flowed at rate of 17 bbls. per hr. Tub. Press. 200#, casing press. 900#, OGR 2800 to 1. Treated well again with acid on November 6th using 2000 gals. Western acid pumped through tubing. Max. press. 2800#, min. press. 1700#. Pumped 800 gals. into formation after break at rate of 1.4 bbls. per minute. Well unloaded and cleaned into pits. After 6 hrs. flow well tested at rate of 32 bbls. per hr. on 3/4" choke. 2.4% H₂S and acid water, gas volume 1872 MCV per day, OGR 2437 to 1. Tubing pressure 250#, casing pressure 0. Still testing well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
