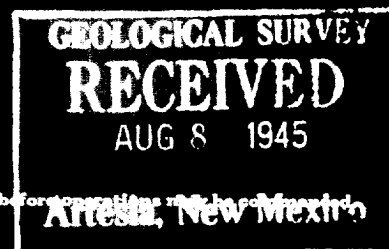

Well plugged from 9861' to 9650' with 90 sacks cement; from 7000' to 6500' with 200 sacks cement; from 5600' to 5100' with 195 sacks cement; from 4200' to 4000' with 100 sacks cement. Heavy mud-laden fluid between each plug. Plugged top of 9-5/8" casing with 50 sacks cement and installed regulation well marker.
