2. Spot 2 bbls 15% HCL-NE-FE acid from 3106'-3024' w/17.5 bbls 9# brine. Perf w/ 2 spf bottom to top at 3104', 02', 3099', 88', 83', 70', 69', 61', 55', 52', 45' & 42'. Set pkr at 3013'. Load backside w/10 bbls 9# brine. Acidize SR 1, 2 & 3 perfs w/ 48 bbls 15% HCL-NE-FE acid. Flush to bottom perfs w/ 19.6 bbls 9# brine.
3. Swd well.
4. Latched on RBP at 3107' & pull up hole to 3037' & test to 1000 psi & hold okay. Spot 2 bbls 15% HCL-NE-FE acid from 3036'-2954'. Perf w/ 2 spf bottom to top at 3035'-3075'. Set pkr at 2920'. Test to 500 psi & monitored. Acidize Yates perfs w/ 56 bbls 15% HCL-NE-FE acid. Flush to bottom perfs w/ 19.7 bbls 9# brine. Swd well.

Instructions
