

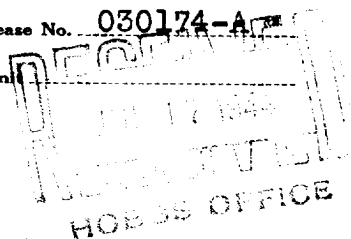

This well produced 14 Bbls. oil thru. tubing on 10 hours test swabbing and flowing.


