

DETAILS OF WORK

To increase production we propose to do the following work:

1. Kill well with lease oil.
2. Clean out open hole section 3125' to 3324'.
3. Run tubing with seating nipple on bottom of string to total depth.
4. Run Gamma Neutron Log from surface to total depth.
5. Pull tubing from bottom into cased hole and install pump equipment.
6. Swab well, recover load oil, test, return well to production.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
