

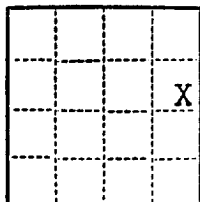

DETAILS OF WORK

Kill well with lease oil and pull rods and tubing. Clean out open hole, 3116' to 3270'. Ran Gamma Neutron Log inside tubing from surface to total depth. Swab and flow well. On 24 hour potential test well flowed thru 10/64" choke 17 BO and no water ending 12:01 p.m. October 27, 1961. Gravity - 35.2, GOR - 37,100.
