Total Depth, 3325' - Lime. 5-1/2" casing cemented at 3154' with 300 Sacks.

After swabbing down, well swabbed at rate of 2 barrels oil per hour. We now desire permission to shoot the section from 3282' to 3325' with approximately 150 quarts of nitroglycerine in an attempt to increase production, Shot will be tamped with gravel, and hole loaded with oil.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
