MI, pull rods and tubing, set CIBP @ 2750' (perfs at 2815-35')

Set cement plug at 2750' to 2600'.

Circulate hole with 10# mud laden brine at 2600'

Shoot 6 5/8" off at 1600' (top Salt at 1650') and pull, setting cement plug from 1700 to 1500'

If casing will not pull, perf and squeeze with 60 sx cement.

Set cement plug from 300' to surface.

Set cement plug from top of last plug to surface.

Install 4" steel marker and restore location.
