Centlemen:

This is to apply for an exception to Order No. 3-610 on our Federal Elliott Well # 1-G, located in Section 6, T-23-5, B-38-E, Blinebry Pool. Lea County, New Mexico.

DeKalb has only one well producing oil and gas on this lease. Our oil production is approximately 110 barrels of oil per month, with a Gas-Oil Ratio of 594/1 making a total of 65,340 cubic feet of gas production per month. The nearest gas pipe line belongs to Gulf Oil Corporation and is taking gas from Gulf Oil Corporation's, H. B. Pike Lease, N/2 of N/2 of Section 6, T-23-S, R-38-E. In order for Gulf to connect our gas into their line it will be necessary to lay approximately 2800 feet of pipe line plus installing metering equipment.

Enclosed you will find a letter from the Gulf Oil Corporation explaining that it is un-economical to go to this expense.

Enclosed also please find plat showing well location, offset ownership, location of tank battery and gas sales lines.
