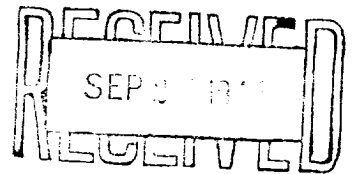

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On September 19, 1945 the well was acidized with 10,000 gallons by Dowell, Incorporated. Time of injection 1 hour and 52 minutes, duration of treatment 2 hours and 30 minutes.

Production before -- In 24 hours swabbed 115 barrels of oil and water, very little gas.

Production after -- In 24 hours swabbed 125 barrels fluid cutting 50% water, showing more gas.
