DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 9 joints 287' of 13-3/8" OD 8 RT 48# H-40 SS Casing. Set and cemented at 302' w/350 sacks Regular Neat Longhorn bulk cement. Plug at 286'. Maximum pressure 150#. Circulated approximately 15 sacks cement.

After waiting over 24 hours tested 13-3/8" casing w/1000# pressure for 30 min. There was no drop in pressure. Drilled cement plug from 286' to 302'. Tested cement below casing shoe w/500# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
