On May 25, Acidized by Western thru 2-3/8" tubing w/8000 gals 15% NE acid thru perf. in anchor at 6871' to 6866'. TP 2000# to 0#. CP 1200# to 0#. Displaced acid w/26 bbls oil.

RESULTS: Swabbed acid water to pits 2 hrs. 9 1/2 hr swab test ending 2:00a.m. May 26, rec 80 bbls oil, 8 bbls water. Well kicked off and 3 hr. flow test rec 80 bbls oil 40 gravity, 10 bbls. water.
