DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 168 joints 7745' of 7" OD 8 RT R-3 23 & 26# M-80 & J-55 SS casing. Set and cemented at 7751' w/325 sacks cement, 225 sacks 4% Gel and 100 sacks neat on bottom. Plug at 7671'. Maximum pressure 1100#. Gulf temperature survey in 12 hours found top cement outside 7" casing at 5478'.

After waiting over 30 hours tested 7" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement from 7671' to 7965', tested cement below casing shoe w/600# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to complete well.
