Ran 10 jts (400') of 9-5/8" OD 32# & 36# H-40 & J-55 SS casing. Set and cemented at 413' w/275 sacks reg Neat cement. Plug at 398'. Max. pressure 200#. Circulated approx. 20 sacks cement. Job complete by HOWCO at 3:45 PM 16th.

Tested 9-5/8" casing w/1000# for 30 minutes. There was no drop in pressure. Drilled cement plug and tested cement below casing shoe w/400# for 30 minutes. There was no drop in pressure.
