Ran 10 Jts (450') 9-5/8" OD 36# Gr H-40 SS casing. Set and cemented at 465' with 325 sacks Regular Neat cement. Plug pumped to 335'. Maximum pressure 300#. Circulated approximately 30 sacks. Job complete 9:PM 6-5-54.

After waiting over 24 hours, tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug and tested cement below casing shoe with 400# for 30 minutes. There was no drop in pressure.
