Ginsberg #8 well (SW1/4 SW1/4 Section 31-25S-38E),
Langlie-Mattix (Ext) Field, Lea County, N. M.,

for the purpose of flaring casinghead gas.

In support of the above application, we submit the following data:

- (3) Producing wells on this lease are:
Ginsberg Nos. 5, 6, 7 and 8.
- (4) Plat attached showing: (a) Well locations; (b) Ownership; (c) Location of tank battery and gas sales lines.
- (5) Permission to flare casinghead gas from these wells requested until such time as El Paso Natural Gas Company, owner of the nearest gas sales line, completes negotiations with surface owner for construction of gas line to the respective wells.
 - (a) Wells producing approximately 50 MCFGPD each.
 - (b) Gas/Oil Ratio: 750 - 1.
