DETAILS OF WORK

This is to supplement our request of Dec. 29, 1951, which approval was granted for suspension of operations. The following work was done at that time plugged back from total depth of 3986' to 3700' with cement. Filled hole with 10# mud to 1340'. Set plug and cemented to 1330', pulled 10 3/4" casing and filled with 10# mud to 1070', set plug and used 50 sks cement. Filled with 10# mud into surface pipe.

We propose to complete plugging operations in the following manner. Place 25 sks. cement in bottom of surface pipe which is set and cemented @ 603'. Fill with heavy mud to top of surface pipe, place 10 sks cement at this point and cement cellar. Fill in cellar and restore location to original condition as near as possible.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
