Holan Bruns n, Inc. set National 13-D JH-80 Pumping Unit. Union Well Service rigged up, pulled tubing and retrieved bumper spring and collar lock at 3600'. Ran 116 joints 2-3/8 tubing and set at 3639'. Seating nipple at 3607'. Ran 2 x 1-1/4 x 12' O'Bannon sub-surface pump, 88 - 5/8" x 25' and 55- 3/4" x 25' sucker rods, 1 - 5/8" x 2', 1 - 3/4" x 2' and 1 - 3/4" x 4' rod sub. Various valves and service installed Waukesha Model X-264-B 30 H.P. gas engine and started well pumping 14 - 48 strokes per minute.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
