Gentlemen:--

On Sept. 23rd, 1966, we wrote you, with a copy to your Hobbs Office, as follows:

"This is to advise that we did on Sept. 2nd, 1966, begin the injection of water into Blainebry Well No. 11, one of the wells listed in the above mentioned order and being located 1300 feet from the South Line and 1240 feet from the East Line of Section 34, Township 23 South, Range 37 East, Lea County, New Mexico.

"We also plan to begin injection of water into Well No. Blainebry 15, one of the wells listed in the above mentioned order and being located 1340 feet from the North Line and 1200 feet from the West Line of Section 35, Township 23 South, Range 37 East, Lea County, New Mexico, this injection to begin Sept. 27th, 1966."


On October 25th, 1966, we filed Form C-120 in triplicate with the District Office, showing the amount of water injected into each of the above wells in September and naming the dates such injection began.

However, the November allowable schedule still shows an oil allowable for Blainebry Well No. 15 and our Fort Worth Office in error reported production for both wells 11 and 15 on Form C-115 for the month of October, 1966.

We are requesting our Fort Worth Office to file a corrected Form C-115 for October and if you will eliminate the allowable for both Wells 11 and 15, we should have the record straight.
