(2) Set Baker Model "N-3" 1.963" OD CIBP @15,420'. Set 7 5/8" Baker Model "D" packer at 14,160'. (3) Ran Baker seal assembly on 434 joints 2 7/8" 9.5# L-80 PH-6 tubing and tagged Model "D" packer. (4) Mixed and displaced well with packer fluid. (5) Perforate 7 5/8" casing at 14,270' - 14,304' with 1 JSPF with 1 9/16" OD Prospector, decentralized, -0- phase gun with 35 shots. Place well on production on 1-29-02.
