May 4, 1968, displaced hole w/mod brine. Spotted 500 gals 15% MEA. Perforated 5513-15' w/4 - 0.45" JHPT.

Fraced down 5-1/2" OD casing w/23,000 gals GB & 15,000 lbs. 20 - 40 sand in 4 equal stages of 1,000 gals GB pad, 6,000 gals GB w/1-1/2 ppg 20-40 sand, 500 gals 15% MEA, and 8 - 1" RCH balls. Flushed w/137 bbls brine.

Ran 2-3/8" OD tubing and set at 5773'. Ran pump and rods completed 5-5-68.

Well pumped 21 BO, 29 BW, 42 MCF gas in 24 hour test ending 5-17-68.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
