Gentlemen:

TEXACO Inc. respectfully requests administrative approval of a non-standard gas proration unit of 120 acres, comprising the NW/4 of the SW/4 and the S/2 of the SW/4 of Section 34, Township 24 South, Range 32 East, Lea County, New Mexico, which will be assigned to the Cotton Draw Unit Well No. 70, North Paduca Delaware Pool.

In support of this application, and in accordance with Rule 3 of the Special Rules and Regulations for the North Paduca Delaware Pool, the following facts are submitted:

1. The Cotton Draw Unit Well No. 70 was reclassified as a North Paduca Delaware gas well effective March 1, 1969.
2. The proposed non-standard proration unit contains less acreage than a standard proration unit and lies wholly within a governmental quarter section.
3. The proposed non-standard unit consists of quarter-quarter sections that are contiguous by a common bordering side.
4. The entire non-standard proration unit is reasonably presumed to be gas productive in the North Paduca Delaware Pool.

5. All offset operators to the proposed non-standard production unit have been notified by copy of this application, and are hereby requested to furnish a waiver of objection to this application to the New Mexico Oil Conservation Commission, Santa Fe, New Mexico.
