This zone T/A with Plug In Otis permatrieval packer at 5920' In 9-17-70. This zone may be re-activated after completion of necessary reservoir study.

The ownership of this property is in reorganization under Chapter X of the Federal Bankruptcy Act. The Trustee of the corporation has not been able to provide funds for the necessary examination of work-over potential. It is anticipated that the company's reorganization will be complete in the latter quarter of 1975 and that funds will then be available to examine the property for workover possibilities and to perform the workover if justified. We request that adequate time be given for this contingency prior to the forced plugging and abandonment of this zone.
