WOC 144 hrs. Rigged up 11-29-68, displaced hole w/brine. Spotted 400 gals 15% NHA on bottom. Ran Schlumberger PDC log from 5873' up to 5900'. Perforated w/4 - 0.45" hyperjets per foot w/3-3/8" OD G-70 carrier at 5499-61', 5595-97', 5714-16', 5796-98' and 5855-57' (40 holes). Pumped in 5,000 gallons 7-1/2% NHA w/1 - 1" ball sealer every 3 bbls. flushed w/40 bbls mod brine. Avg pressure 2900#, AIR = 5.5 BPM, IKIP = 1100#. Pressured down 5-1/2" csg. in 5 stages of 1,000 gals gelled pad, 6,000 gals w/1-1/2% 10/20 sand per gal. Last 4 stages preceded by 8 - 1" RCW balls and 500 gals 15% NHA flushed w/139 bbls mod brine. Max press 4000#, 29.5 BPM, IKIP 1100#. Ran 2-3/8" OD tbg, set at 5845', S/N at 5813'. IPC tbg on top of string. Ran rods and pump, released unit 12-4-68. Well pumped 109 BO, 49 BW, 129 MCF gas in 24 hour test ending 12-12-68. GOR = 1183, gravity 40.5.
