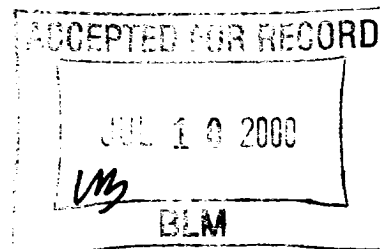

Well was purchased from Vista Resources effective 3-1-2000. Notification from OCD office in Hobbs stated that well was currently producing from two zones downhole without commingling approval. Prize requested and received approval from the OCD (5-12-2000) to shut-off the lower perforations (13256-14014) Atoka. On 6-15-2000, Prize set CIBP at 13,250' with 10' cmt on top of plug. RIH with 2 7/8" tbg and set pkr at 10,452'. The Strawn (Wildcat) perforations (130274-040) is the only producing interval now in this well. Work completed on 6-21-2000.
