The following work has been completed on this well:

1. Set CIBP @ 4420' and dumped 2 sx (20") cement on top of plug.
2. Cut 4-1/2" casing @ 3560'. Pulled 350' of 4-1/2" casing.
3. Loaded hole w/9.6# mud.
4. Spotted 20 sx cement plug from 3500'-3580'.
5. Spotted 25 sx cement plug from 1100'-1200'.
6. Spotted 25 sx cement plug from 287'-387'.
7. Spotted 10 sx cement plug at surface.
8. Clean location and installed 4" marker extending 4' above ground level.
Plug and abandoned December 29, 1971.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
