Surface casing: Used 8 5/8", 20#, H-40 casing set at 1150 with 450 sacks of cement.
Oil string: Used 4 1/2", J-55, 9.5# at 3800' with 250 sacks.
- Blowout preventer: 10" Cameron SS series 900 double hydraulic with Payne closing unit on the 8 5/8" casing. No abnormal pressures have been encountered in this area and none are anticipated.
- Drilling mud: Fresh water will be used to drill surface hole. Salt water gel and starch will be used as necessary to control water loss to total depth.
- Auxiliary equipment: A sub on the floor with a valve to be stabbed in the drill pipe when the kelly is not in the string.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 2: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 3: Needed only when location of well cannot readily be found by road from the land or lease description. A plat, or plat, separate or at this reverse side, showing the lands to be surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.

Item 4: If well is to be, or has been directionally drilled, give distances for subsurface location of hole in any present or objective production zone.

Item 5: Consult applicable Federal or State regulations, or appropriate officials, concerning approval of the proposal before operations are started.
