Drill to top of anhydrite at 1300' and set 8-5/8" surface pipe, circulate cement. Drill out with blowout preventer Shaeffer 10" Series, 800 LWS, 3000# working pressure and 5000# test to oil string casing point at 3500'. Log well and run 5-1/2" oil string and cement to base of salt. Rig up cable tools and drill into Seven Rivers Reef under cable tool control head.

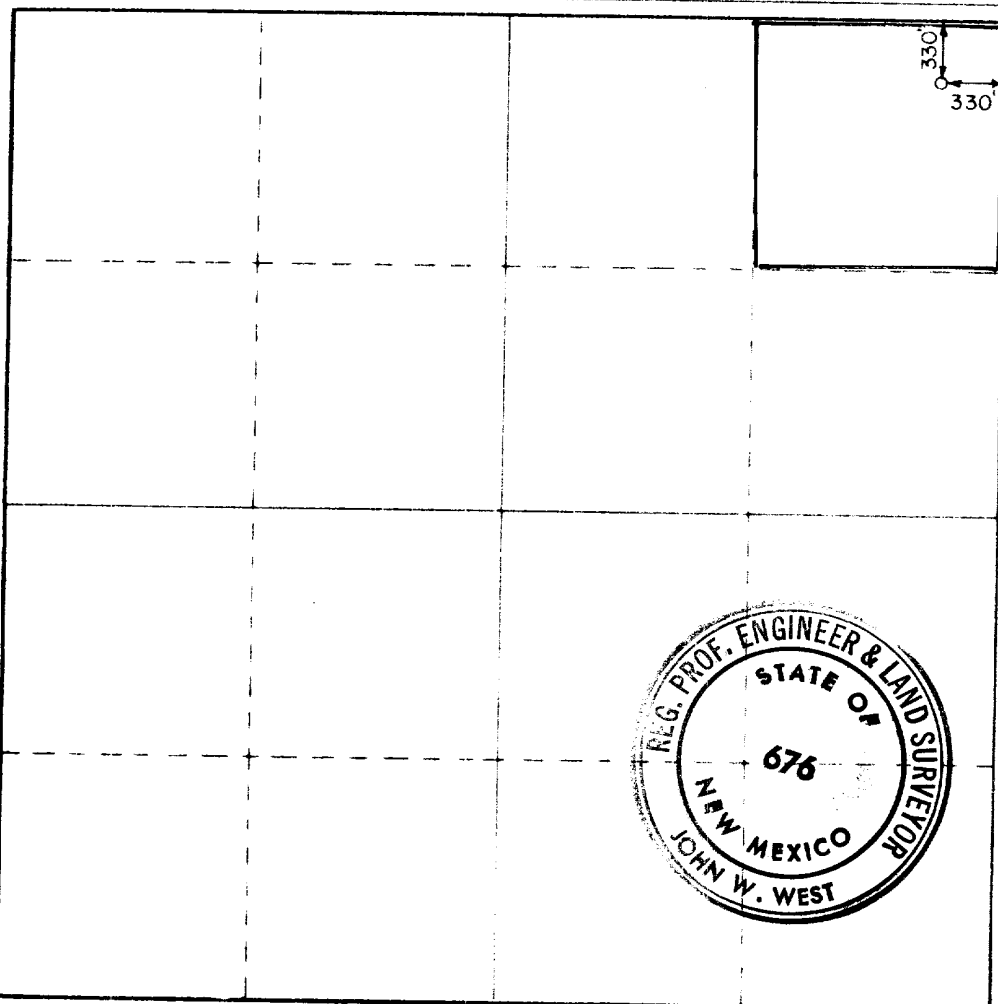
