40.50 (1 jt) 16" 65# H-40 BTX-over
106.85 (3 jts) 16" 65# H-40 BT
797.62 (19 jts) set at 797.60 (shoe) with stab in float collar at 749.64'
Installed centralizers on jts 1,3, 5, and 6. Cemented with 450 sx HLW + 1/4# flocele (12.4 ppg - yield 1.97) tailed in with 300 sx Class "C" + 2% cc (14.4 ppg - yield 1.4) Circ 75 sx good cement to surface. PD at 9:30 PM 5-28-79. WOC a total of 32 hours. Tested casing to 600 psi - 30 minutes - ok. Reduced hole to 14-3/4" and drilled ahead.
