Drilled well to a total depth of 3360'. Ran 93 joints (3364') of 5 1/2 OD, 17 lb/ft, J-55, ST&C casing and landed at 3360 feet RKB. Cemented casing with 350 sx of API Class-C cement containing 3% Halliburton Econolite and 1/4 lb/sx Floseal followed by 150 sx of a 50-50 blend of API Class-C cement and Pozmix "A" containing 18% salt and 1/4 lb/sx Floseal. Plug down at 4:00 AM CDT 10-24-79. Circulated 87 sx of excess cement to pit. WOC 18 hours. Pressure tested casing to 1500 psi. Pressure held okay.
