1. Rigged up, Buster well service on 3-05-03, Ran 2 3/8 Fiberglass tubing with packer and set @ 4328', installed 2 3/8 WKM Master valve, plumbed surface casing to surface for Meter for backside.
2. Set 2-250 BBL & 1-500 BBL Fiberglass storage tanks on caliche pad, set pump for SWD, built dirt dike around tanks & pump, installed 4 wire barbed wire fence around outside of dike.
3. Rigged up MacLasken Truck and tested backside @ 500 PSI for 30 min. on chart (attached).
