We would like to request a continuance of shut-in status due to lack of market and pipeline connection.

The shut-in pressure of the well head is 1980 psi.

This lease is being maintained in an active status beyond its primary term by the annual payment of \$640.00. Minimum royalty payment is due on or before April 1 of each year. A payment was made in February 1988 for the period covering April 1, 1988, through April 1, 1989.

PLAN OF OPERATION:

We have been and will continue to actively pursue negotiations with a purchaser to connect this well. Enron has refused to allow us to connect this well due to the need for compression and the high line pressure. We have negotiated with El Paso but they are presently not taking low pressure gas in this area because their system is overloaded. We hope to have this well connected by year end but due to the unpredictability of the gas market we cannot be certain. We will continue to maintain this lease by the annual payment of minimum royalties.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
