PROCEDURE:

- NOTE - ATTEMPT TO SET C.B.P APPROX 50' ABOVE PERFS W/ 35' CMT ON TOP.
1. Load 2-7/8" tubing with 10 ppg brine, ND tree, NU 5000 psi. BOPs.
 2. PU on 2-7/8" tubing and pull seal assemble out of PBR @ 13,007' or to maximum of 145,000#. If unable to pull out of PBR, RIH abd cut 2-7/8" tubing @ 12,975'±.
 3. POH to 12,950' and spot 20sx plug from 12,950' to 12,700'. WOC and tag.
 4. Calculate free point of 5-1/2" seal lock casing. Estimated recovery 6,500'.
 5. RIH with 2-7/8" tubing and spot 100sx plug (50sx below and 50sx above) across 5-1/2" cut off. TAG
 6. POH with 2-7/8" tubing and spot 20sx plug from 5,300' to 5,200' (BASE OF SAL & INT. CSG)
 7. POH and spot 35sx plug from 660' to 560'.
 8. Spot 10sx plug @ surface. Cut off wellhead 4' below GL. Weld on dry hole marker. Clean and level location. (OVER)
