This request has already been approved by NMOCD Commingling Order CTB-432.

Also requested is off lease measurement of Casinghead gas at meter run located at tank batter of Conoco Federal Lease, Unit Letter I, Section 19, T-26-S, R-32-E, Lea County, New Mexico. AND the off lease measurement of oil at tank battery located on the Conoco B Federal located in Unit Letter M, 990' FSL and 330' FWL, Section 20, T-26-S, R-32-E, NMPM, Lea County, New Mexico. The oil production will be allocated by well tests (each lease has only one well).

This will be the most cost-effective way to keep these three marginal wells in production.
