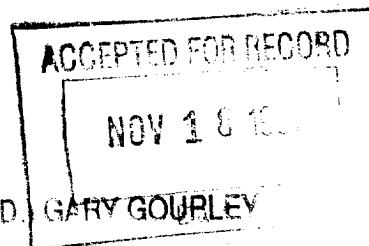
1. Set CIBP @ 5500' +/- w/20' cement cap.
2. Perforate at selected intervals w/0.50" hole - 2 JSPF
 - A. 5362-5374 - 26 holes
 - B. 5304-5320 - 34 holes
 - C. 5270-5280 - 22 holes
 - D. 5236-5246 - 22 holes

3. Acidize each interval w/500 gal. 15% HCl.

4. Swab & Test.
