5/27/94: Cement 8-5/8" casing w/ 1350 sx "C" PSL containing 9 pps salt and 1/4 pps Flocele. Tail w/ 200 sx Cl "C" + 2% CaCl<sub>2</sub>. Plug down at 1:00 a.m. MST. Circ'd 68 sx pit. WOC. Cut off, weld on head. NU BOP's. Test BOP's and casing to 1500 psi, OK. PU BHA and TIH. WOC total of 23 hours. Resume drilling operations.
