Howco cemented w/ 450 sx Class "H" + 5 pps Microbond + 2.4 pps KCl + .6% H-322 @ 15.6 ppg. Displace cement and land plug. Plug down @ 1200 hrs CST 12/16/94. TOC @ 6400'. ND BOP's and make cut-off. Weld on wellhead and test to 2500 psi.
