5/19/95: Spud. Drld a 12 1/4" hole to 545'. Ran 12 jts 8 5/8" 28# BTC csg and set @ 545'. Used four centralizers. Cmted w/lead 230 sxs 'C' + 4% gel + 2% CaCl2 + .25 pps celloseal, tail w/150 sxs 'C' + 2% CaCl2 + .25 pps celloseal. Circ to surface. WOC 18.25 hrs.

Drld a 7 7/8" hole to 3250'. Ran 75 jts 4 1/2" 11.6# K-55 csg and set @ 3250'. Used twelve centralizers. Cmted w/lead - 450 sxs 'C' Lite + 6% gel + 5% salt + .25 pps celloseal, tail w/225 sxs 'C' + 3 pps KCL + .5% CF-14. Circ to surf. WOC 8 days.
