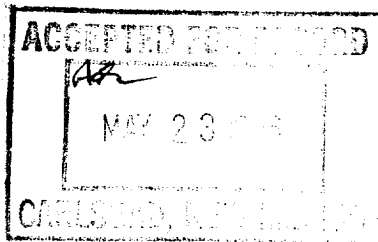

1/18/96: Spud. Drld a 12 1/4" hole to 567'. Ran 13 jts 8 5/8" 24# K-55 and set @ 567'. Used four centralizers. Cmted w/lead - 230 sxs 'C' + 4% Bentonite + 2% CaCl2 + .25 pps celloseal, tail w/150 sxs 'C' + 2% CaCl2 + .25 pps celloseal. Circ. to surfac. WOC 13.25 hrs.

Drld a 7 7/8" hole to 3133'. Ran 71 jts 4 1/2" 11.6 K-55 csg and set @ 3133'. Used twelve centralizers. Cmted w/lead - 380 sxs 'C' lite + 6% Betonite + 5% salt + .25 pps celloseal, tail w/365 sxs 'C' + 3 pps KCL + .5% CF-14A. Circ. to surf. WOC eight days.
